

Dever Building Dedication

Brown Township Maintenance Building Renamed as the Dever Building

In a sometimes emotional May 29 gathering, the Brown Township Board of Trustees named the building housing the township hall and maintenance facility the Dever Building, in memory of long-time trustee, the late Gary Dever. Trustee Pam Sayre presided over the dedication ceremony, remembering, in particular, Gary's ability to read a room and defuse difficult situations.

"At times, he was my friend, my dad, my mentor, and always our trusted trustee," she said.

A lifelong Brown Township resident and farmer and a township trustee for 47 years, Gary Dever was honored for his dedicated service to Brown Township.

A second ceremony the same evening featured the planting of two October Glory maple trees in the nearby Brown Township Nature Preserve to honor Gary Dever and his wife, the late Sophie Dever, a long-time teacher at Brown Elementary

New Trustee Appointed

The Brown Township Board of Trustees has appointed Pete Marsh to fill the Board vacancy created by the death of long-time Trustee Gary Dever. He will serve the remainder of Dever's term, through December.

A ten-year resident of Brown Township, Marsh is a landscape designer and owns Blue Oak Patio & Landscape in Hilliard.

He served on Hilliard City Council for six years and was a founding member and one-time chair of the Environmental Sustainability Committee and served on the board of Destination Hilliard.

Currently, he is a member of the Hilliard Chamber of Commerce Board of Directors, the City of Hilliard Planning & Zoning Commission, and is involved in a start-up non-profit organization called Home in Hilliard which will soon offer services to residents 55 and older.

He has been participating in the Brown Township Comprehensive Plan Steering Committee and sees the Trustee appointment as an opportunity to be more engaged with the community in which he resides.

Marsh notes that residents of the portions of Brown Township that are also within the city of Hilliard are sometimes confused about the overlapping layers of government.

A native of Bowling Green, Ohio, he received a bachelor's degree in accounting from the University of Notre Dame and a master's degree in landscape architecture from The Ohio State University.

Marsh and his family – wife, Bev, and daughters Clare (12), Violet (11), and Anna (6) – are active in the St. Brendan parish. He also coaches two of his daughters' softball teams.

He feels strongly about local service and looks upon this opportunity as a way to serve and to help bridge the gap between concerns of rural residents of the township and those who live in incorporated portions of the township, as he does.

Fellow Trustee Pam Sayre says, "We feel very fortunate to have Pete with us. He brings a wealth of community experience and a fresh perspective to the Board."

Brown Township Awarded "Housing Technical Assistance Program" Grant Funding by State of Ohio

Zoning in Brown Township is currently administered by the Franklin County Economic Development and Planning Department. This office oversees all zoning, code enforcement, and land use planning activities in our township.

Other local townships that also outsource these functions include Clinton, Franklin, Hamilton, Madison, Mifflin, Norwich, Pleasant, Sharon, and Truro. Local townships that administer their own zoning include Blendon, Jackson, Jefferson, Perry, Plain, Prairie, and Washington.

By the end of 2026, Brown could join the list of townships that administer their own zoning.

In the past year, the Brown Township Trustees have undertaken several efforts to respond to the increased pressure for development throughout the region. To date, the most visible form has been in the undertaking of a Comprehensive Plan Update.

Our Comprehensive Plan was last updated in 2005 and certainly many things have changed since then! Out of this process came the seedlings of an idea to consider self-administered zoning regulations. As development continues to knock on the doorstep, it makes sense that we take greater control of setting our own zoning regulations and enforcement so that we can support the community that we want, rather than having those decisions made for us at the county level.

In early June, Brown Township was notified that our grant application to the Housing Technical Assistance Program for funding the development of a township zoning code was successful.

In total, the Ohio Department of Development awarded \$1.5 million in grants to 29 cities, villages, and townships across 20 counties.

Brown Township was the only local government in Franklin County to receive this funding. We will receive \$50,000 to be put toward the process of developing and implementing a township zoning code. This effort is ex-

- GRANT from page 2 pected to cost \$140,000 and so this important source of state funds will cover over one-third of that total.

To fulfill the grant requirements, the process must be completed by the end of May 2026. This will require a great deal of work in a short period of time!

Brown Township will once again partner with Verdantas as our consultant on this project, the same firm that is assisting with the Comprehensive Plan Update that is concluding.

This process will include a new Working Group of residents to provide input throughout and many other opportunities for broader community feedback through public forums and open houses. Stay tuned for more information about how to become involved!

After a proposed zoning code has been finalized, it will be placed before the voters for adoption in the fall 2026 election. If successful, the township will develop plans for processes and personnel to administer the new code, as well as the creation of a Planning & Zoning Commission to be comprised of appointed members of the community.

This is not a small undertaking and there are a lot of steps to get from here to there.

There will be a strong need for resident input and involvement at each step along the way.

In the end, the result that we hope for is to have Brown Township better positioned to control our own destiny.

With local code development, local land planning, and local code enforcement the residents who live here will be the ones who are making decisions about how we want our community to move forward together.
